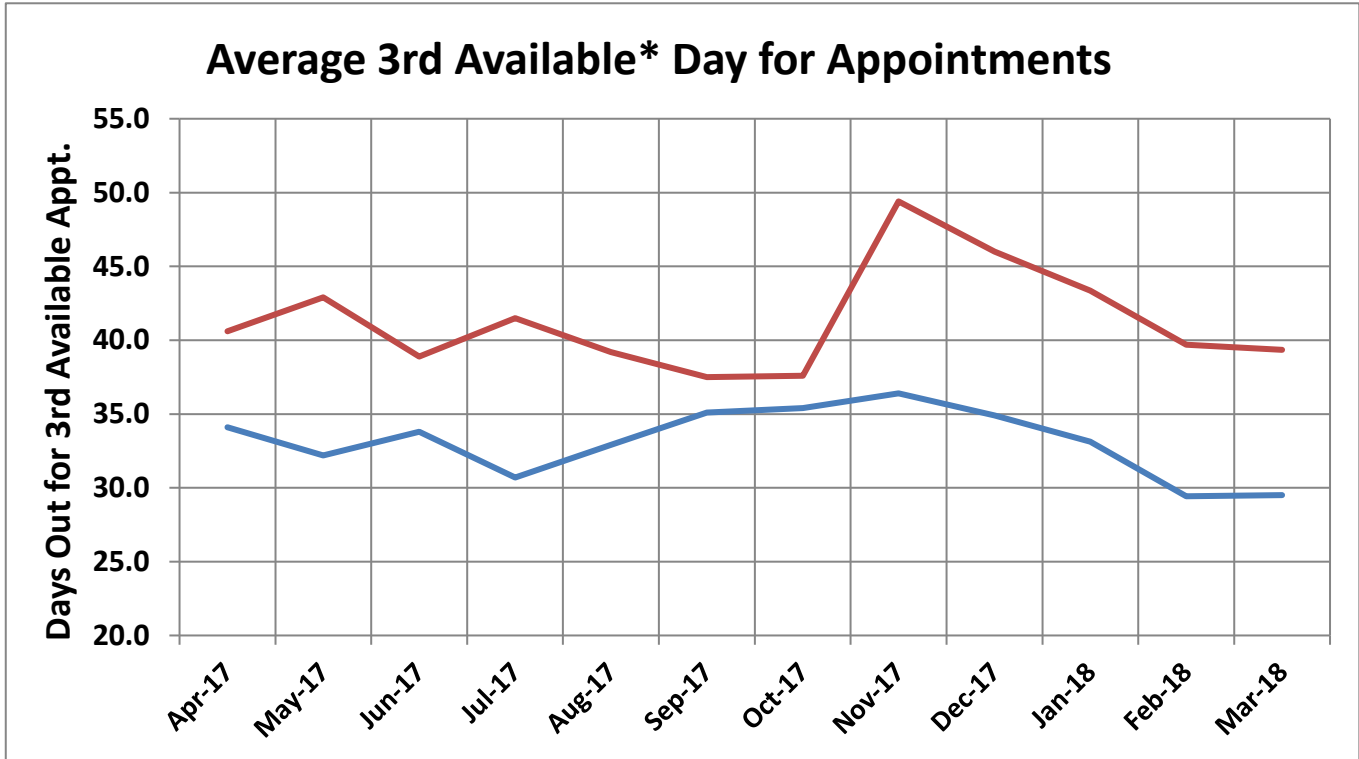

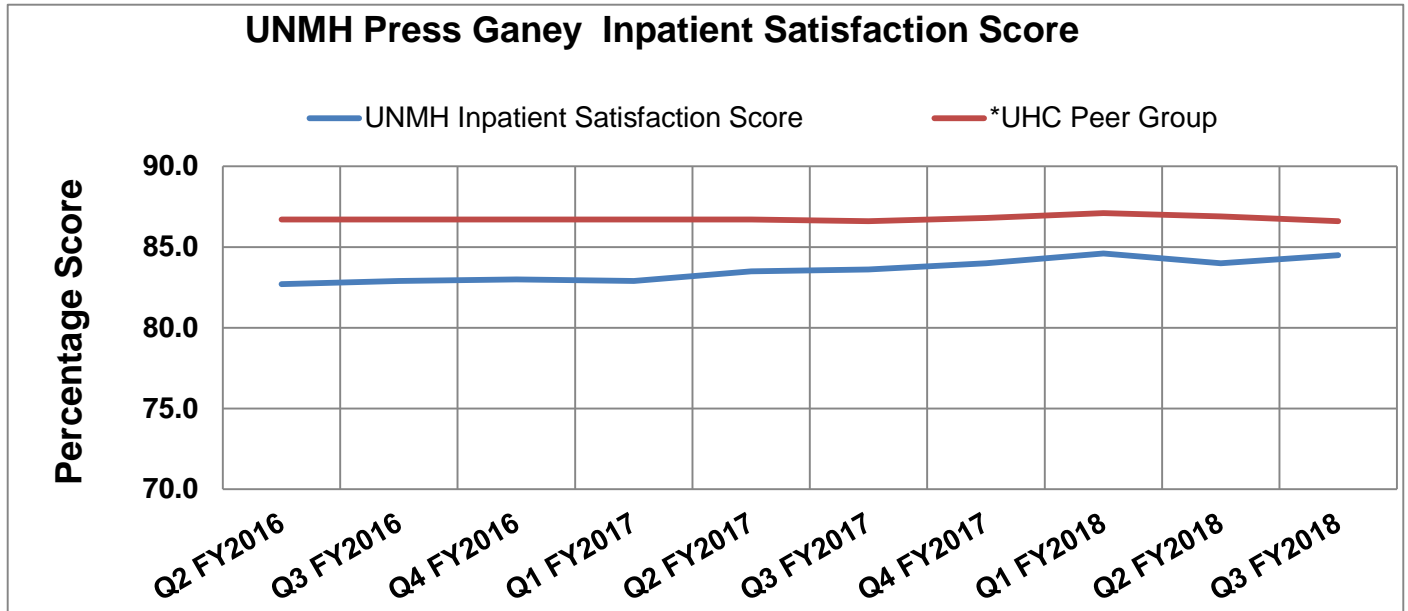

**Average time for an Appointment for Primary Care and Specialty Care Clinics**


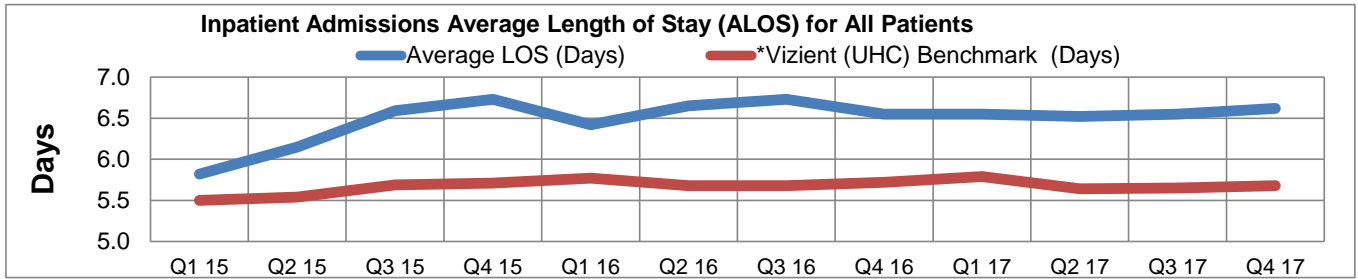

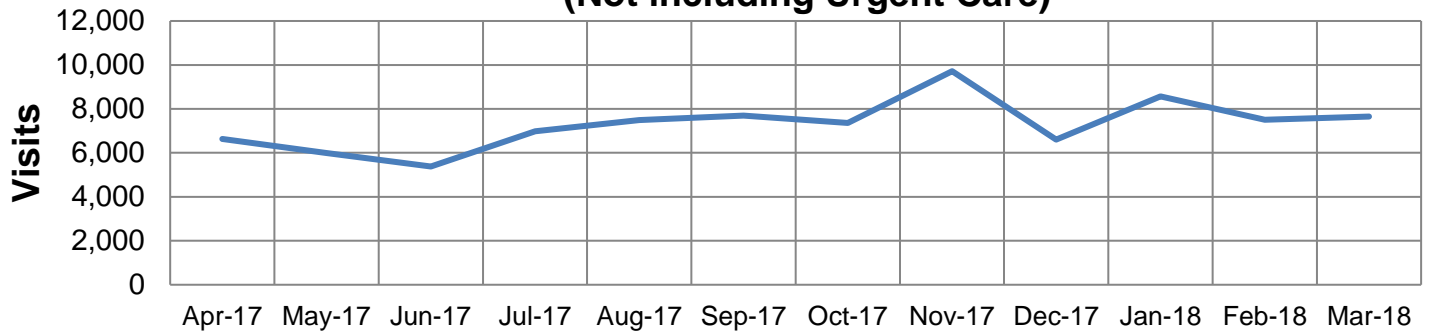

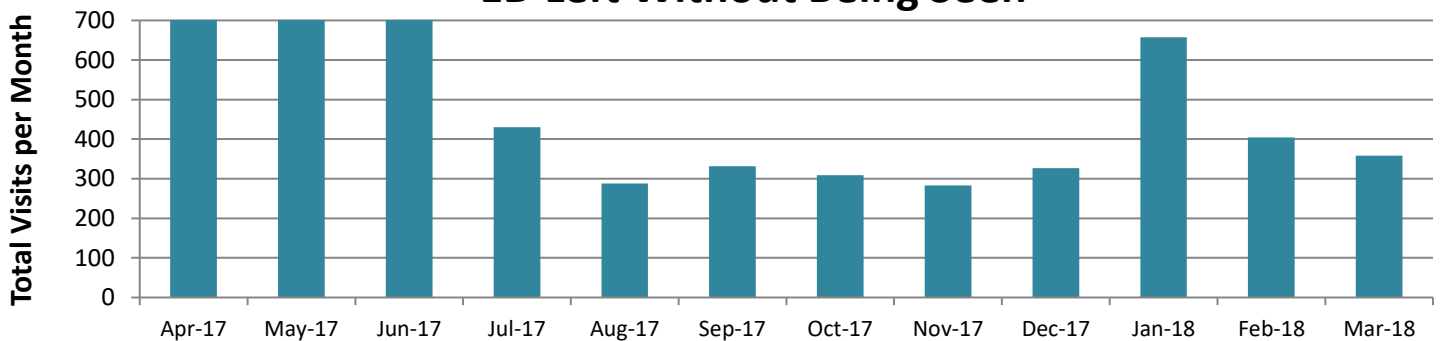

## Emergency Department (ED) Visits (Not including Urgent Care)



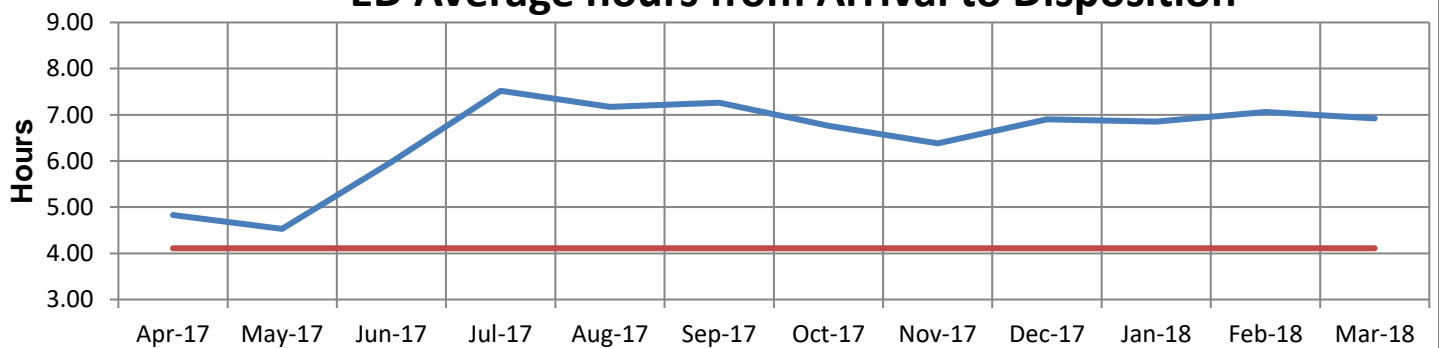

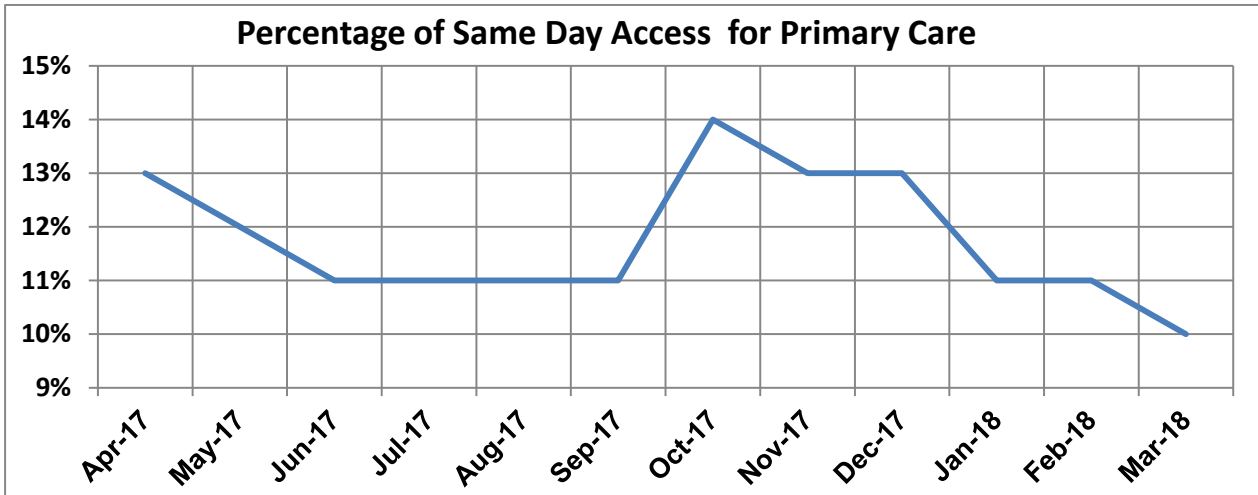

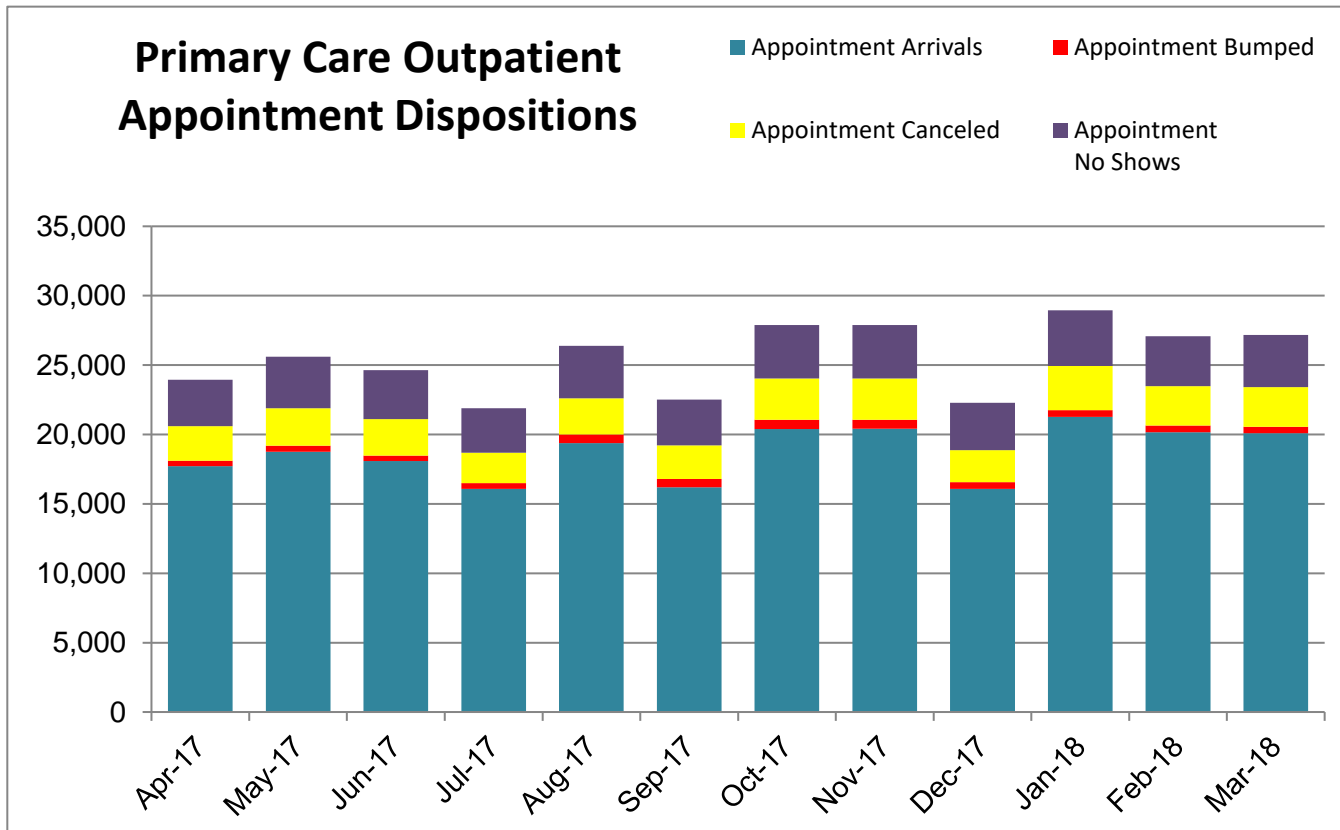

**Most Recent Three Month Same Day Access Average by Clinic**

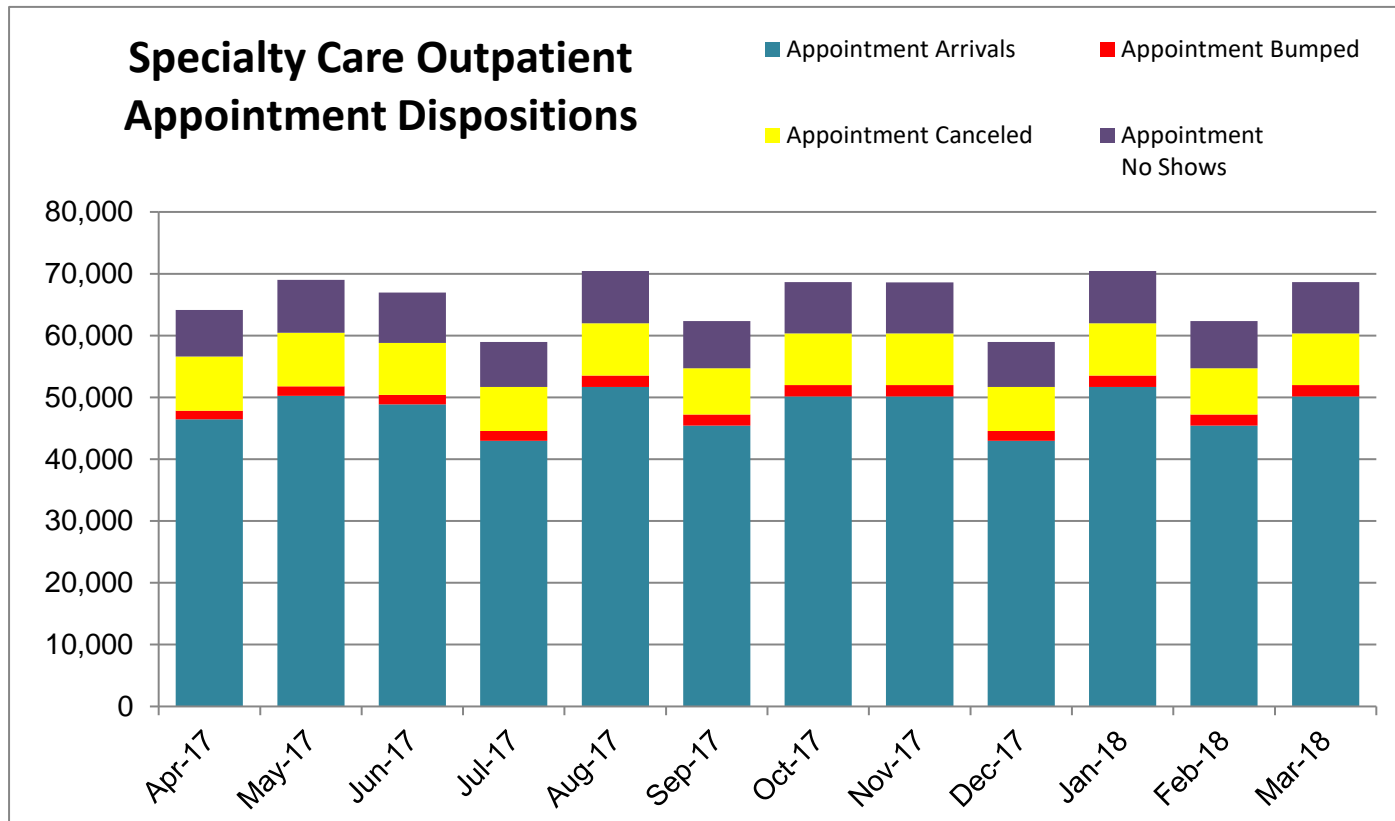

## Behavioral Health Average Length of Inpatient Stay

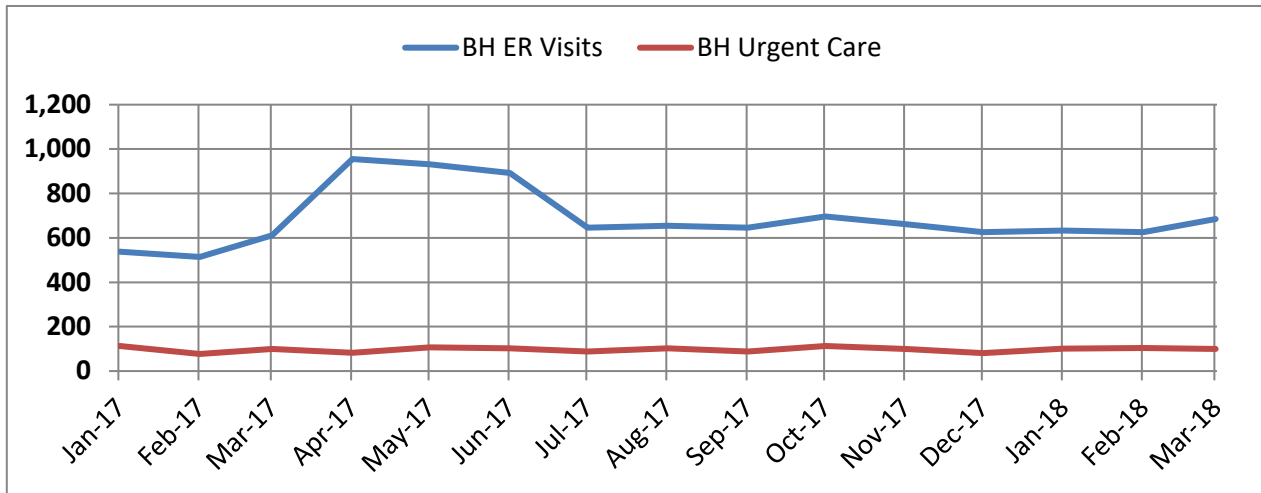
