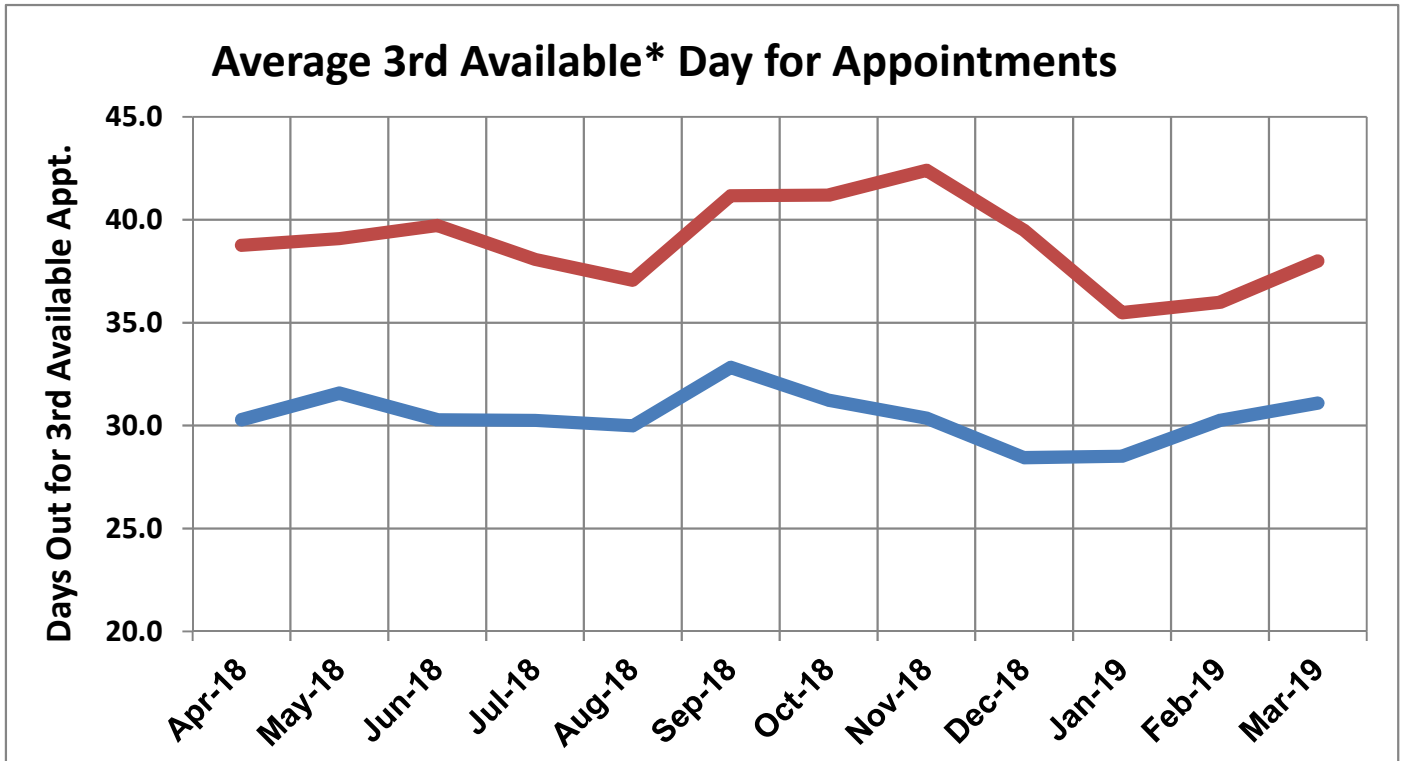

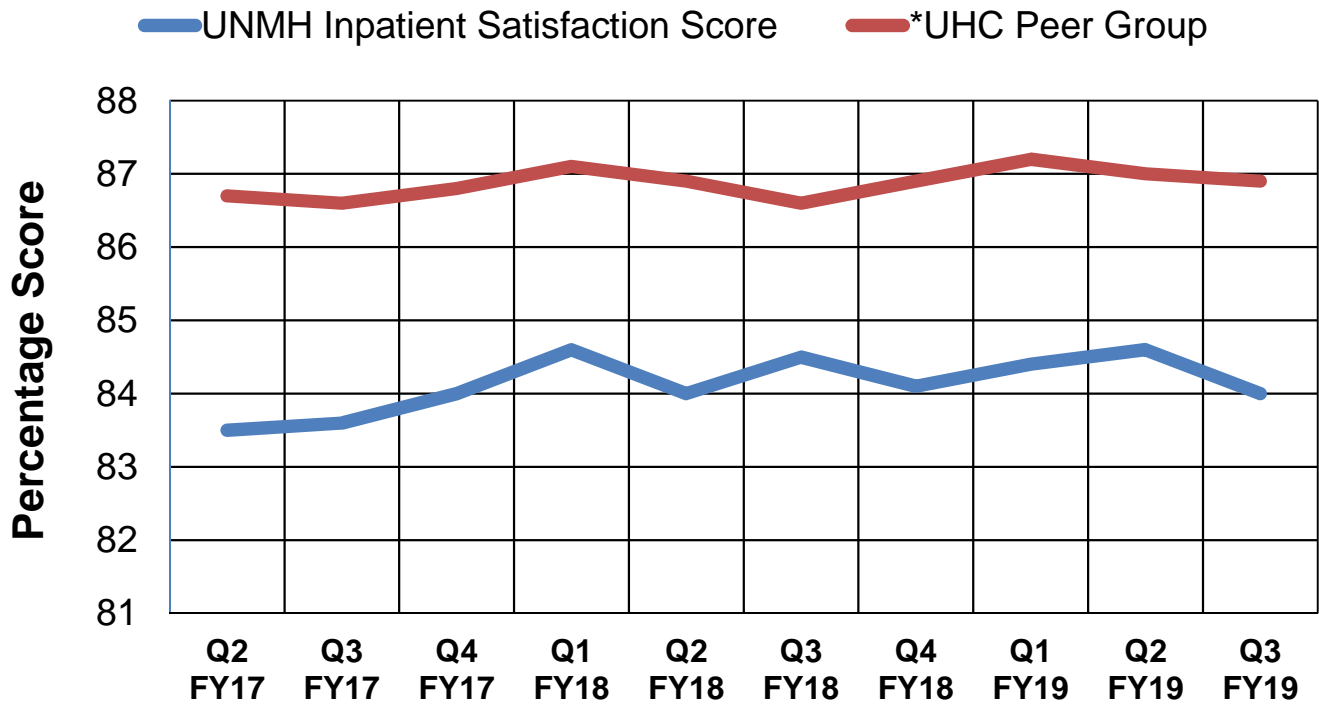
Average time for an Appointment for Primary Care and Specialty Care Clinics

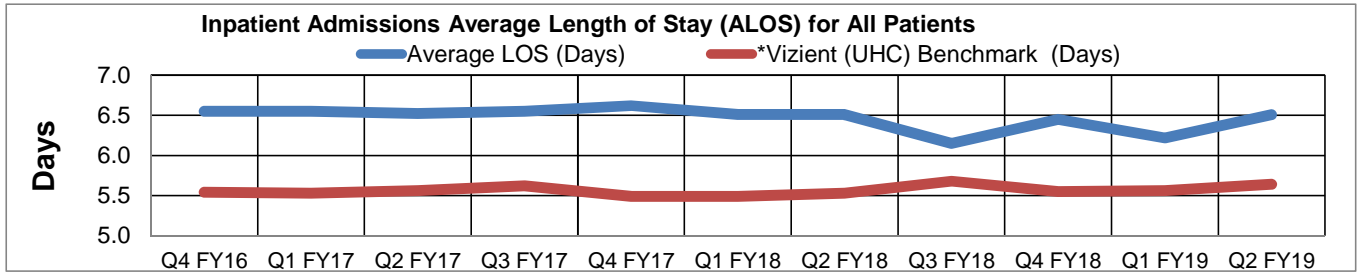

UNMH Press Ganey Inpatient Satisfaction Score



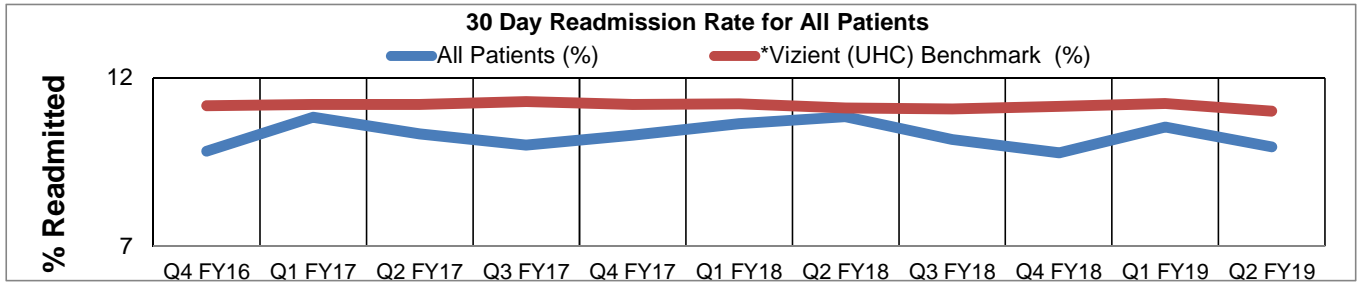

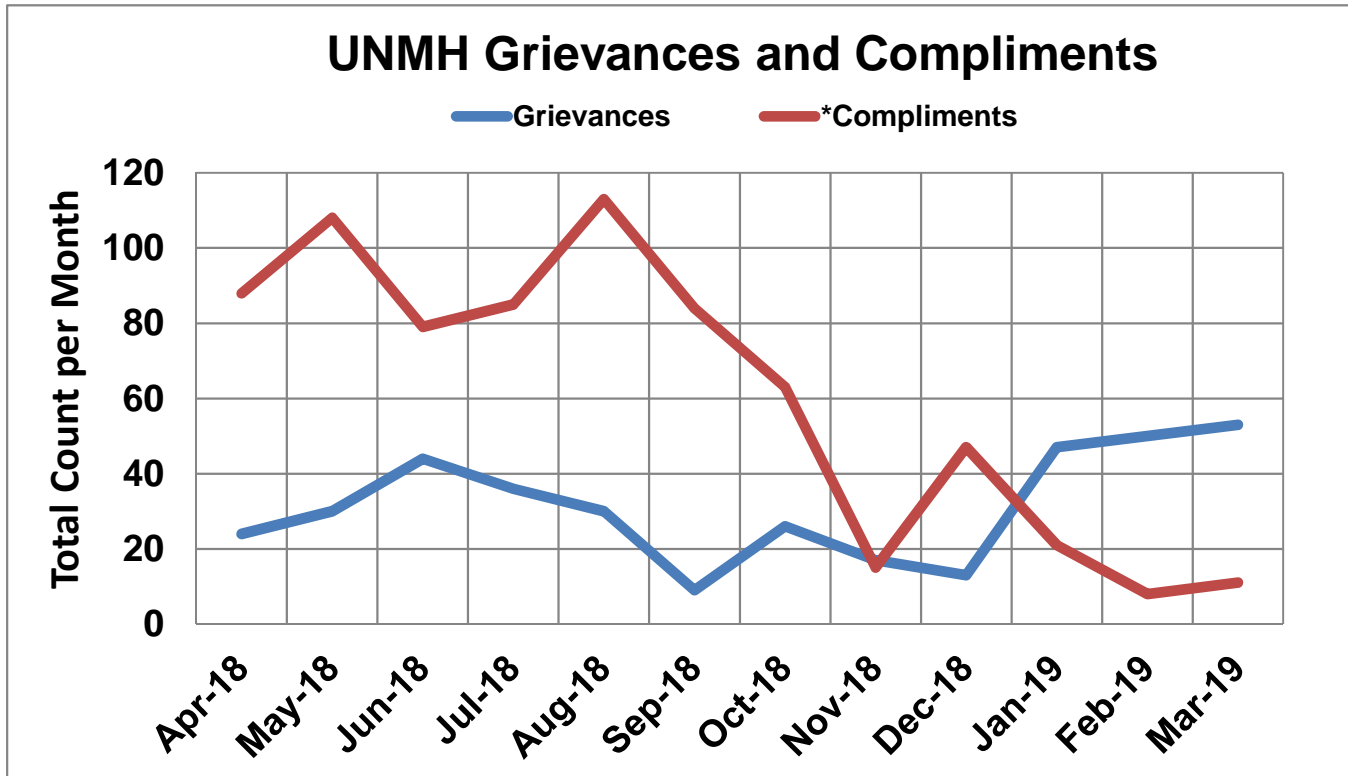

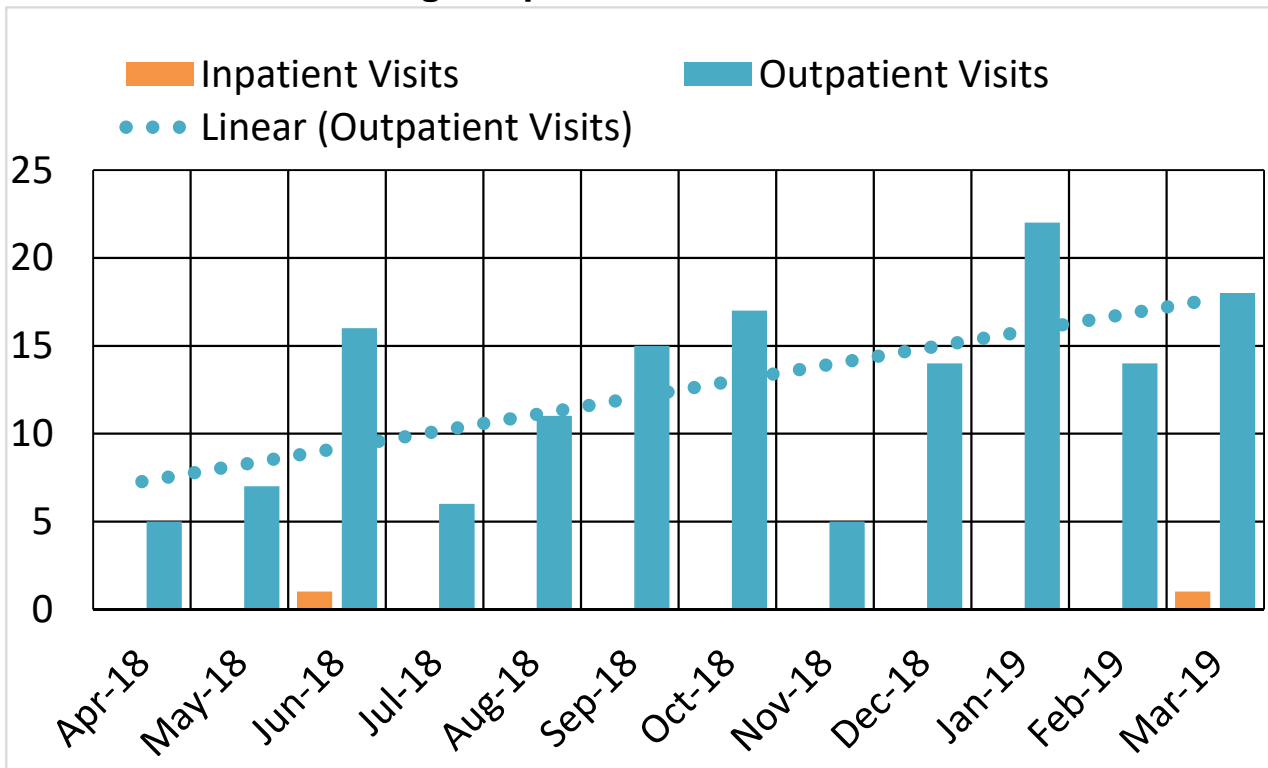

MDC Inmates Receiving Hospital Services

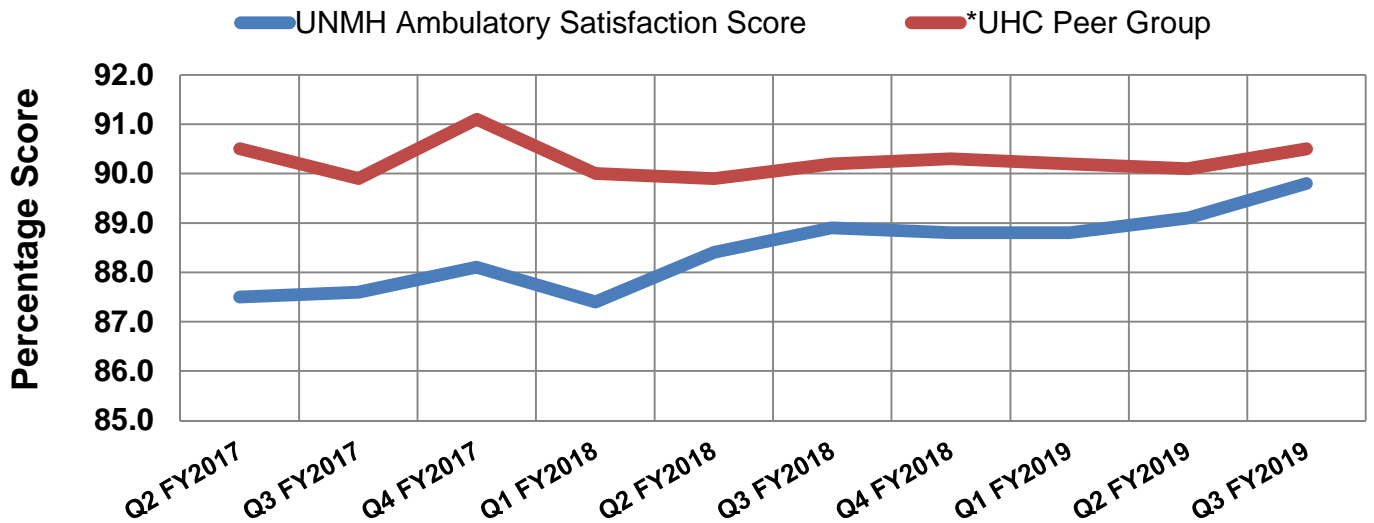

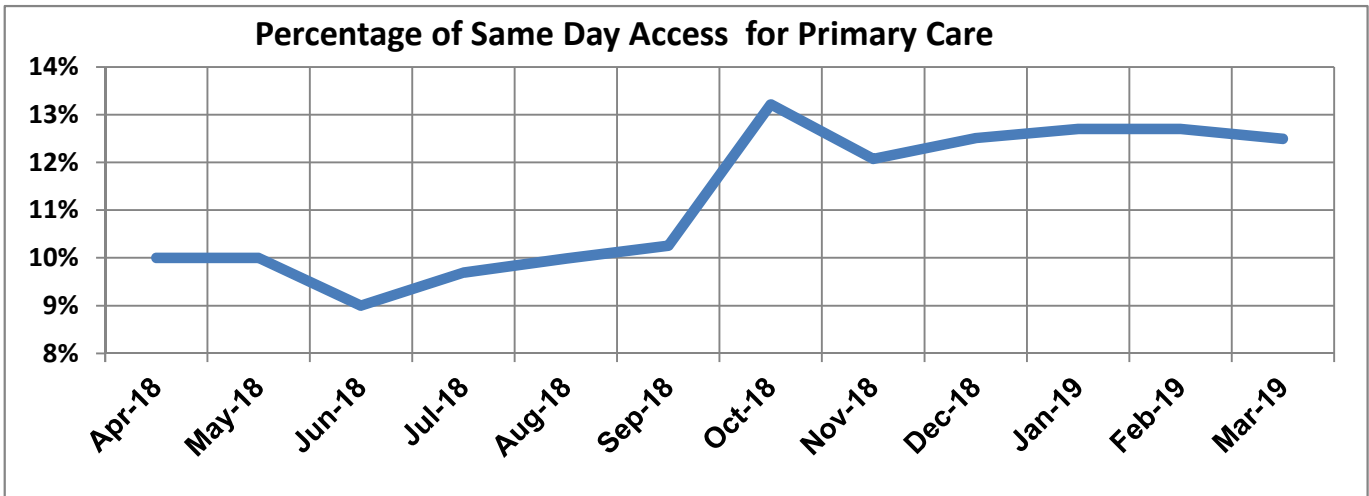

Percentage of Primary Care Patients with same day clinic appointment



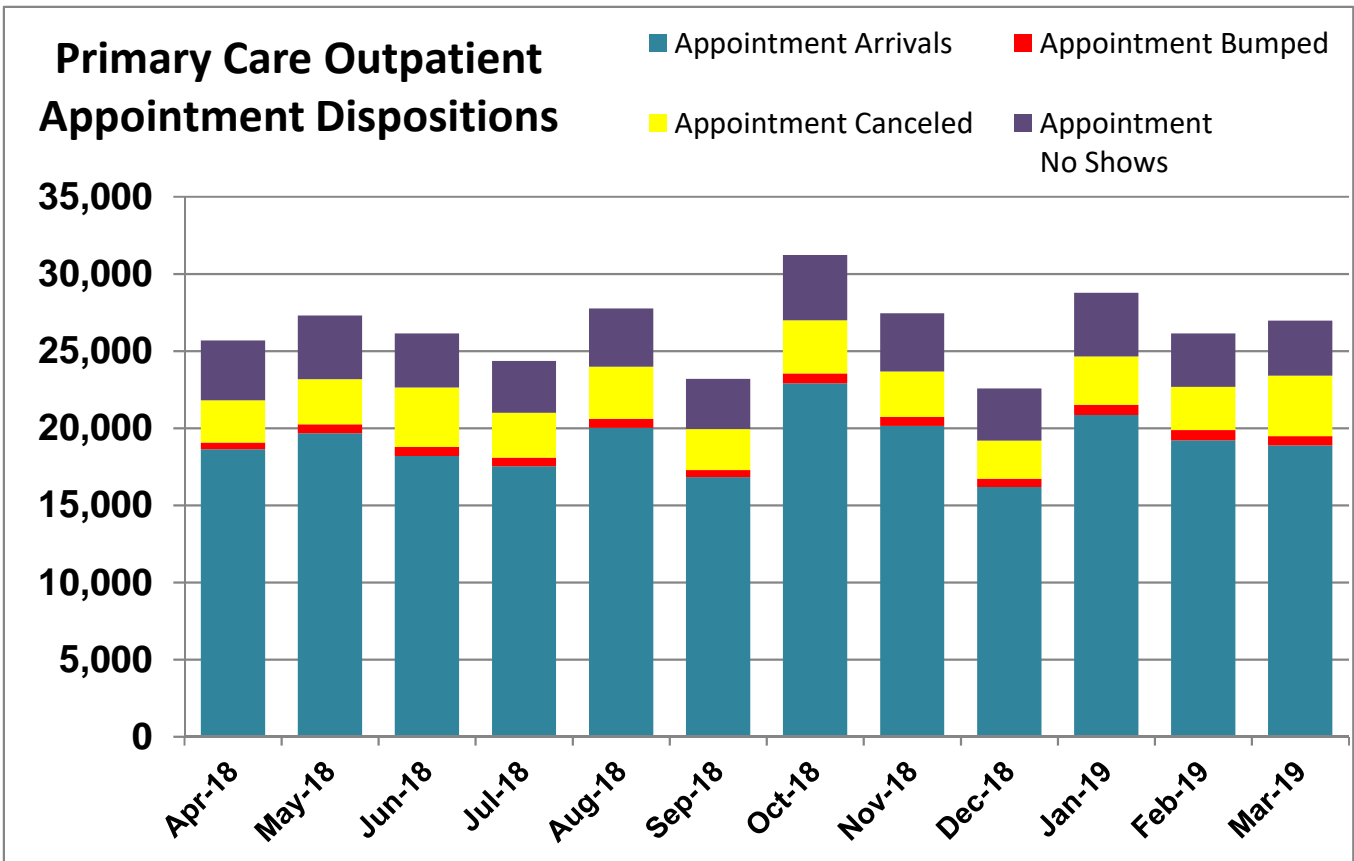

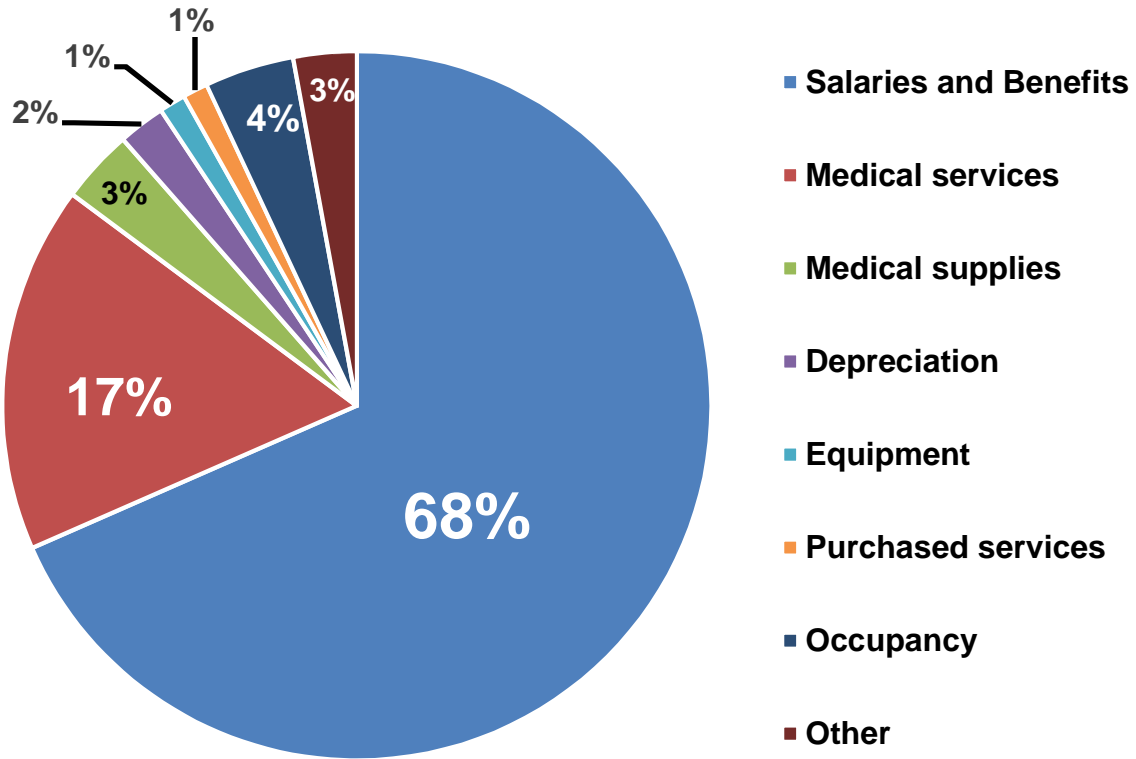

FY2018 Mill Levy Expense - Behavioral

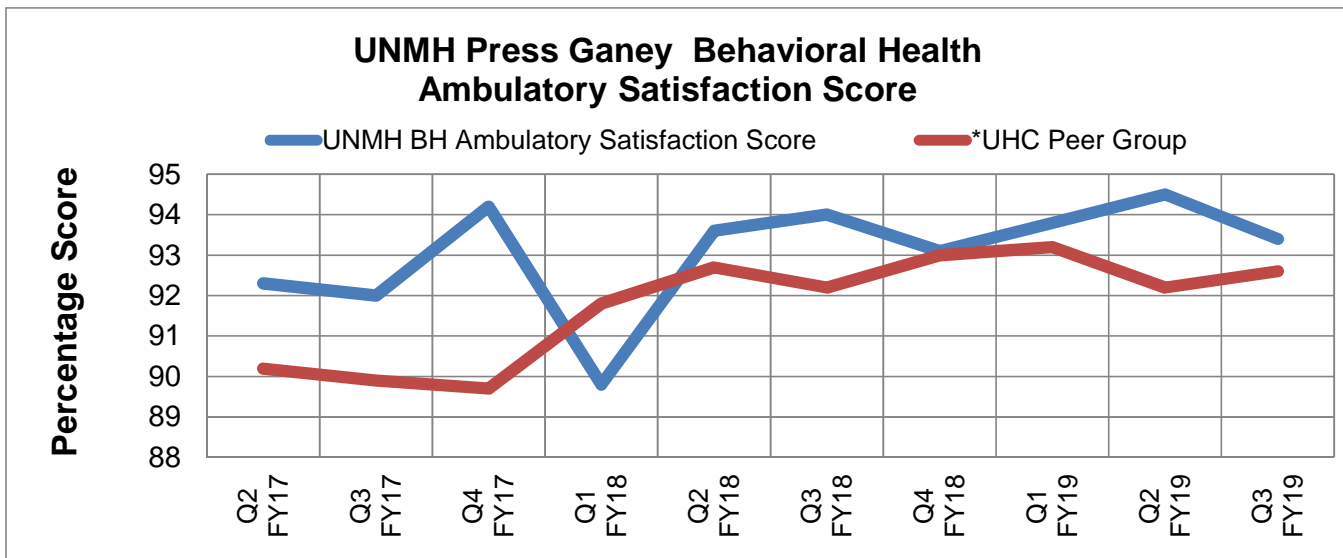

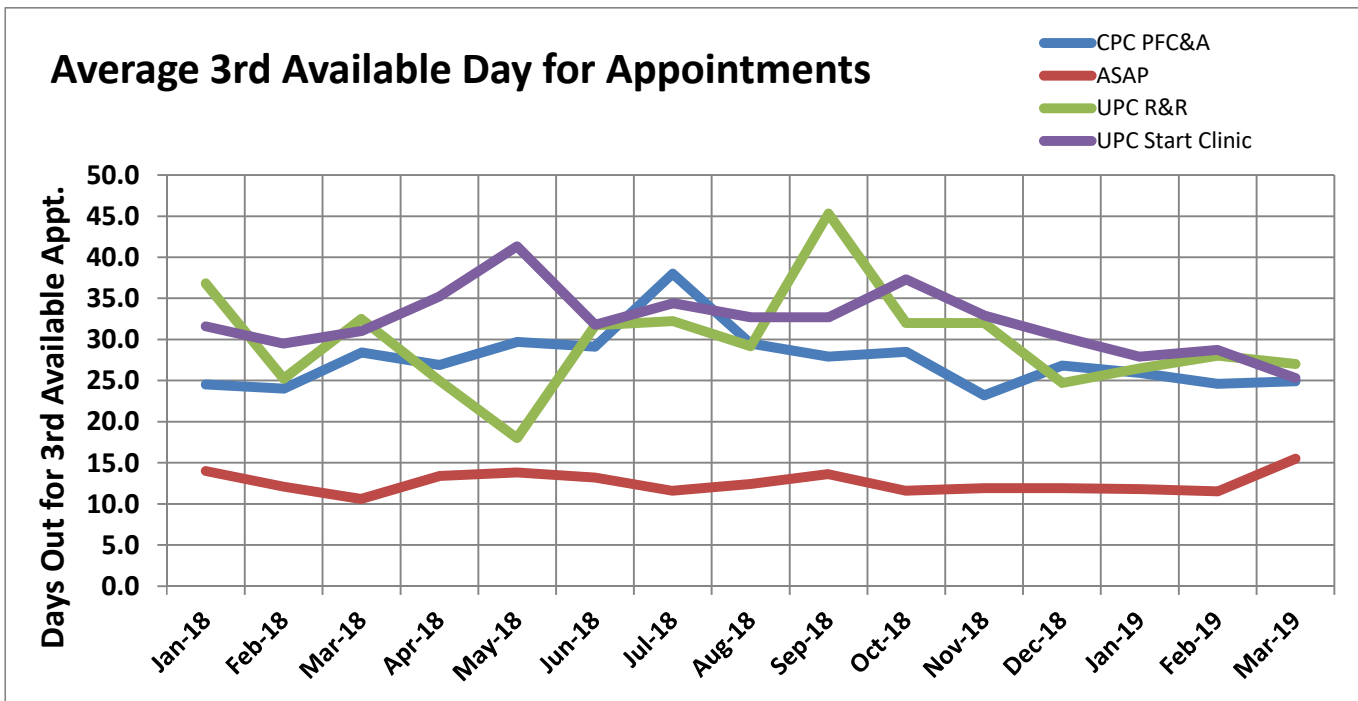

Average Appointment Time for BH Outpatient Services

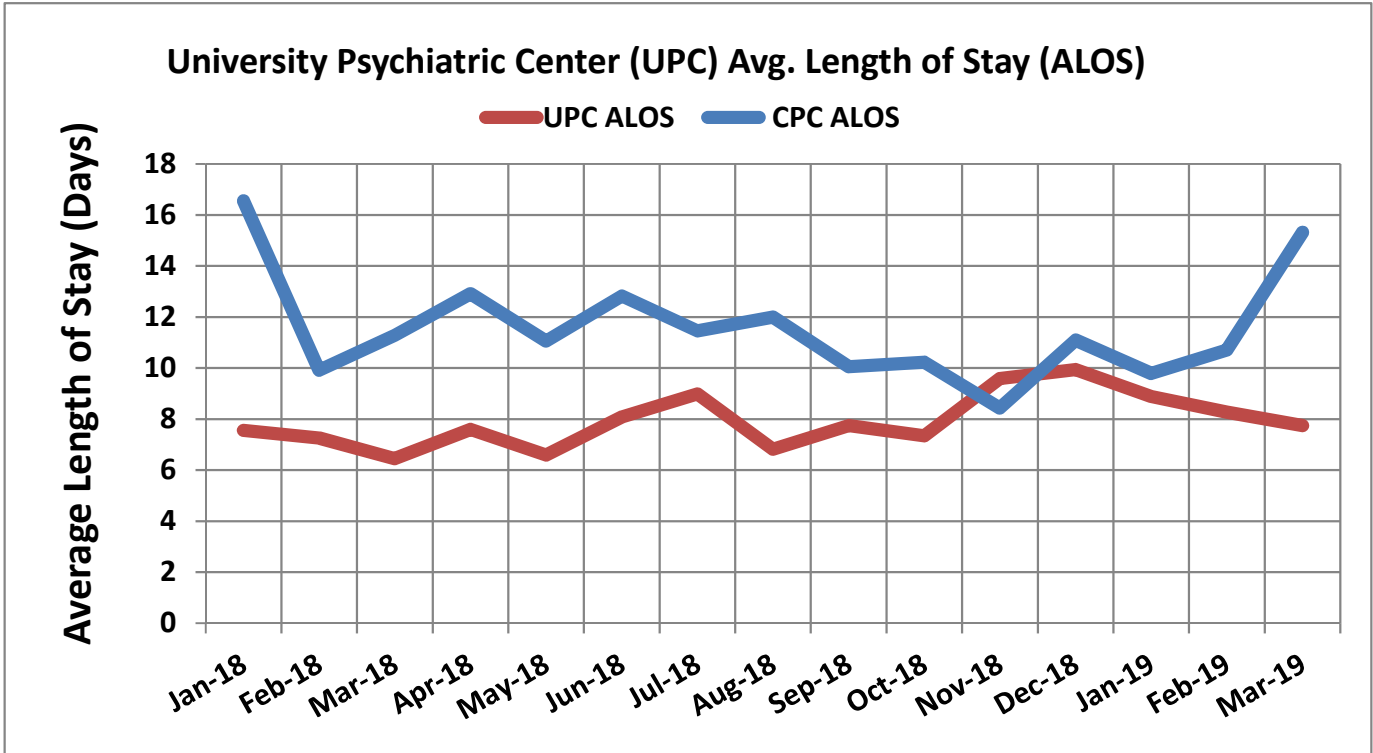

Behavioral Health Average Length of Inpatient Stay

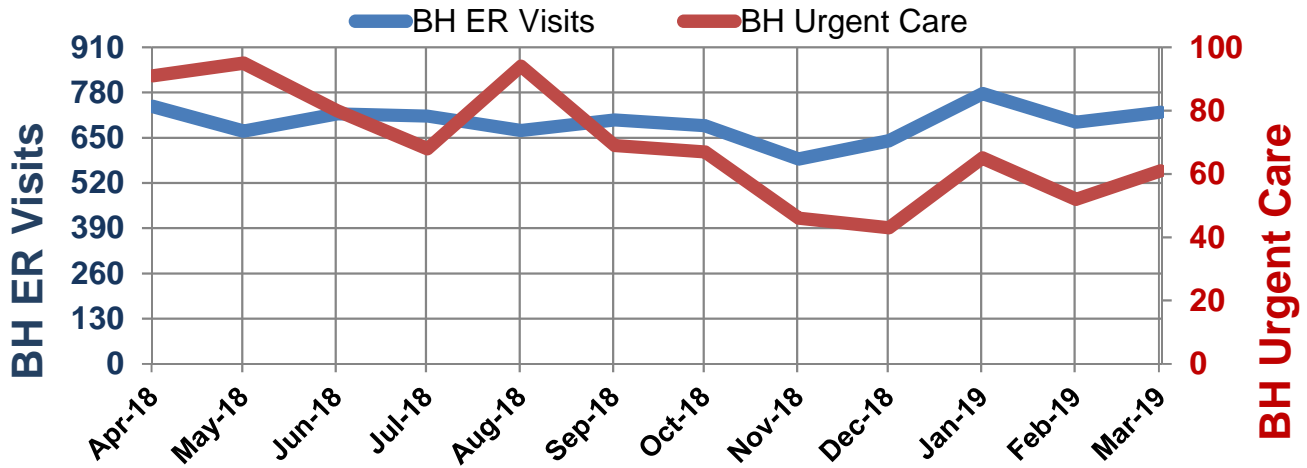
