Why Parent Training?

The Parent Home Training (PHT) Program is not a direct therapy program for your child but a program to teach families skills for promoting development long after the consultant has left the home. The PHT approach is guided by the belief that parents are the best and most natural teachers of their young children. Research has also shown that there are numerous benefits for both child and parent when caregivers are actively involved in treatment for children with ASD. Working within the strengths of the current parent-child relationship, PHT consultants can help caregivers integrate research-based techniques into daily interactions with their children.



Frequently Asked Questions:

Who is eligible to receive services?

Any family of a child under the age of 6 with a medical diagnosis or educational eligibility of Autism Spectrum Disorder (e.g., Autistic Disorder, Asperger's Syndrome or PDD-NOS).

Who provides services?

Services are provided by trained consultants with a range of backgrounds including education, behavior analysis, psychology, social work, and speech-language pathology.

How long are services provided for?

Services are short term and the program usually lasts 3-4 months. The number of sessions varies.

What is the cost?

Services are provided at no cost for families.

What geographical regions are served?

PHT services are available in every county and corner of New Mexico. Telehealth and phone call consultations may be used in some cases.

What languages are services available?

The PHT program employs both English and Spanish speaking consultants. Interpreter services for other languages are available upon request.

What topics are addressed?

Individualized goals are set in consultation with your consultant based upon families needs. Common topics include:

- ♦ Understanding ASD
- ♦ Accessing Resources in NM
- ♦ Increasing Communication
- ♦ Building Social Skills
- ♦ Improving Transitions
- ♦ Tackling Toilet Training
- ♦ Addressing Problem Behaviors and Meltdowns
