

What's new in government benefits?

Policy, case law, and legislation around government benefits is an ever-changing reality that can significantly affect individuals that receive them. Once per quarter the PFE newsletter will cover the most impactful changes to keep professionals up-to-date so the information they provide is accurate and supports individuals in the most current way possible.

<u>Policy</u>

Changes to SSI and Stimulus Check Rule

The Social Security Administration previously ruled that the stimulus checks, also known as Economic Impact Payments (EIP), during the pandemic would not be counted against a beneficiary's \$2,000 resource limit for twelve months. In a significant change as of August 1st, the stimulus checks in addition to unemployment insurance and other financial assistance programs will not count against the resource limit. SSA has updated their <u>Coronavirus webpage</u> that outlines and answers questions you may have.

<u>Case Law</u>

The Supreme Court of the United States (SCOTUS) is hearing a case on Supplemental Security Income (SSI) for residents of Puerto Rico. This case involves an individual from Puerto Rico, but also would set precedent for other individuals in other U.S. territories including Guam, the American Virgin Islands, and the American Samoa Islands that also pay taxes for SSI, yet are ineligible for receiving SSI. <u>An overview of the case can be found here.</u>

Legislation

House Resolution 3824 (H.R. 3824) known as the Supplemental Security Income Restoration Act of 2021 is proposed legislation to make changes to the SSI program. These changes include eligibility, benefits amounts, repealing the marriage penalty, removing in-kind support and maintenance, exclusion of retirement accounts, and many other aspects of the legislation and policy that deny individuals benefits and require that individuals have significantly limited income and resources to receive government support for financial and healthcare support.
